As per guideline, the receipt of **processing fee for Rs.40, 100/- (Rupees forty thousand one hundred) is sent herewith. The original affidavit sworn by the President of Seemanta Engineering College on non-judicial stamp paper worth Rs.105/-** is also sent herewith as per instruction of AICTE.

It may please be noted that as per earlier practice we have already sent processing fees in favour of Member Secretary for the existing programmes of the Institute, both for B.Tech and M.C.A. during August,2009 when compliance were sent vide letter No. 2473 .dated 27.8.2009 including DD for Rs.50,000/- vide DD No. 395580 dated 20.8.2009.for B.Tech, and Vide letter No.2429 dated 22.8.2009 including DD for Rs.50,000/- vide DD.No 395581 dated 20.8.2009 for MCA , and those DDs were received at Regional Office, Kolkata on 31.8.2009.

However, as per requirement of AICTE for submitting online information, this Institute has also paid Rs.40, 100/- towards processing fee and Rs.10, 100/- as earnest money. Since processing fee was paid earlier for extension of approval for the academic session 2010-2011 and if AICTE feels that this amount paid is an excess payment, it is requested to refund it or adjust the excess amount in future.

Further it is to state that for the deficiencies pointed out by the AICTE during approval of extension of this Institute for 2009-2010, the compliance on deficiencies were reported to AICTE vide this office letter NO. 2473 dated 27.8.2009 and No.2429 dated 22.8.2009 , copies of which are annexed herewith for ready reference.
