	<p>Continue.</p> <p>2. (i) The AICTE pointed out shortfall of instructional area to the quantum of 1926 Sq meter. On this point it is pointed out that the Institute has already proposed for construction of separate multistoried academic building for ENTC and E&amp;I department within the campus of the college. The tender has already been finalized and the building is due for construction for which raw materials like iron rod, bricks sand have already been procured and stored at the site. The ground floor of the building will be about 8,761.05 Sqr. Meters and the Institute expects its completion within a time of one year. It is to be stated that once this new block is completed the shortfall of instructional area of this Institution will be removed for ever. Besides construction of additional extension to existing building of build up area measuring 615 Sqr. Meters has already started.</p> <p>(ii) On the Question of shortage of faculty in Electronics &amp; Instrumentation Engineering Department it is to submit that the shortage has already been removed. Presently the faculty strength of E&amp;I Department is 13 which was 9 during the year 2008-2009.</p>
